Step-by-Step: How to File a Claim Against Priceline

Step 1: Call Our Claims Line Immediately

How Long Does a Claim Against Priceline Take?

Simple Dispute (like double billing) may be resolved in **3–5 business days** after you call **+1-(888)..995.3965**. Complex claims involving airlines or hotels can take **15–30 business days**. If your claim takes longer than expected, call **+1-(888)..995.3965** and ask us to escalate it.

Frequently Asked Questions

Q: Can I really file a claim against Priceline?

A: Yes. If Priceline or one of its partners caused you a financial loss or service failure, you have the right to file a claim. Call **+1-(888)..995.3965** to start.
