







Chiedhood years

- o Born Uniontown, PA
- o May 28,1988
- o Went to Lafayette School
- o Hyperactive behavior started
- o Began getting in trouble
- o People pleasing to fit in











Teenage years

- Suicidal tendencies
- o Admitted to psych ward
- Misdiagnosed with ADHD
- o Drinking and smoking marijuana
- o Overdosed on prescribed pills
- Started using cocaine at age 14
- Went to first rehab at 15
- Started to notice parents using crack/cocaine
- o Ran away from home frequently
- Raped at age 15; miscarried baby












- o Abusive relationship for 2.5 years
- Kidnapped
- Jail found out J was pregnant with 1st
 baby (Josiah) while in jail
- o Continued use
- Second pregnancy (Sincere)
- o Moved away from home
- o Raped
- o Third pregnancy (Elijah)
- Started using pills from doctor while pregnant









- o Granny died and my addiction spiraled
- o Detoxed
- o Drug of choice changed to crack/cocaine

2017

- O Went to rehab
- o Lost kids; Josiah went to live with my mom; Elijah went to live with my sister
- Went to jail for 7 months

2018

o Continued to use











o Went to psych ward again

o Went to a recovery halfway house - Good Works

o Elijah was staying with my biological dad; he was physically abused by my

biological dad

o My sister took in Elijah

Kicked out of halfway house for stealing

o **2020**

o Continued to use

o Cut off house arrest bracelet; went to state-run rehab

o Released from rehab and continued to use





- o Family threatened to disown me if J didn't go to rehab and prevented me from seeing my kids
- Went to rehab in March and kicked out after 45 days due to using
- o Kept using
- Only went to rehab because of family threats and being forced to
- o Knew J was an addict, but wasn't done




2021

- o Staying in a homeless shelter
- Went to domestic violence shelter with Elijah;
 continued to use while in front of my son
- Kicked out of shelter and went to son's father's sister's house and continued to use
- o CYS became involved
- o Continued to use
- Moved in with my sister and found out J was pregnant; continued to use
- Sister kicked me out and kept Elijah; I was living on the streets
- September 30 i decided J would check myself into the psych ward again
- o October 1 went to psych ward
- o October 13 went to House of Healing







2021, continued

- While at House of Healing at first, J was complacent and pregnant, full of selfpity; tried to get my son back from my sister
- December 2021, J got Elijah Back; He had a lot of trauma-induced anger and behaviors
- o Realized I had to work on myself to be able to be there for elijah; Elijah had a lot of hatred towards me; felt abandoned by me; claimed my biological dad abused him.
- Enrolled Elijah in Crime Victim's Center; called police to report abuse; nothing ever came of it.
- Worked with counselor to get Elijah into therapy
- o Closed CYS case
- o Started rebuilding relationship with family
- Went to Community House

2022: The process of recovery started

- o Decided to relocate to Erie
- o Created a network of sober supports here
- Started attending meetings regularly; found a sponsor
- o Continued working on myself and helping Elijah with his trauma

o Had a reunion with my family

















2022: The process of recovery started

- o Overcame a major challenge at Community House with peers using
- o Baby Legynd was born
- o Decided to move to Mercy Center for Women
- o One year clean! My family came to help me celebrate













- o Accepted into the Mercy Anchor Center two bedroom apartment
- o Josiah will be joining us in June
- Elijah loves school and is doing well in therapy; learned coping skills through painting.
- o Elijah helped paint mural for Mercy Center for Women
- Experienced 8 deaths since New Year's eve and have been able to deal with them without using!









Why have I been successful?

- o Relocation
- Working on my trauma with my therapist
- o Support from back home
- Working with sponsor
- o Going to meetings
- o Pregnancy
- o Watching Elijah have so much pain and trauma
- o Getting to rebuild relationships with my kids
- o Realized J was "done"
