### **Overview**

Practitioners in rehabilitation may challenged to combat the repetitive of activities that can lead to boredom, decreased therapy engagement, and decreased outcomes. Virtual reality offers an opportunity to innovate rehabilitation practices. Virtual reality (VR) and mixed reality (MR) are currently not widely adopted rehabilitation modalities. Many rehabilitation programs do not utilize VR as a tool to attaining goals and outcomes. The decreased utilization of VR/MR may be due to decreased knowledge of research, clinical time required for use, access to the technology and technology operation. This course will discuss both the practice of including virtual reality in rehabilitation exercises as well as patient and caregiver engagement practices. In order to keep patients engaged, practitioners involved in rehabilitation, both inpatient and outpatient, need to know strategies to discuss difficulty topics with family member, be able to engage both the patient and family/caregivers in the course of rehabilitation, and appropriately refer patients to community resources.

### **Learning Objectives**

Having attended this activity, attendees will be able to:

- 1. Recognize how immersion and embodiment can improve patient engagement.
- 2. Integrate therapeutic activity analysis into a virtual reality experience.
- 3. Identify current motor disabilities barriers to using virtual reality/mixed reality and methods of minimizing these barriers.
