INTRODUCTION

At the most basic level, this program is intended to help you improve your competence and confidence in recognizing and managing violence risk across a variety of clinical settings. Just as most agencies expend considerable resources to develop staff skills around suicide risk management, this training is intended to provide similar tools for violence risk management. Initially built to the needs of crisis work, the training has been adapted for use in other healthcare settings and has considerable relevance for law enforcement and criminal justice professionals as well.

TARGET AUDIENCE

Health providers in mental health, addictions, primary care and emergency medicine who are interested in effectively recognizing and managing people at risk of violence. The content is also extremely relevant for risk management, legal, and security or law enforcement professionals with an interest in preventing violence.

OVERALL GOALS OF THE CHAMPIONS TRAINING PROGRAM

- Impart a practical, memorable, and usable framework for recognizing and managing violence risk in clinical settings.
- Create training that engages and uses multiple learning styles for adult / professional learners.
- Provide a training experience that is interactive, timely, engaging and enjoyable.
- Use recovery and risk-mindful values in the training.
- Deliver content that is in full alignment with clinical best practices and institutional standards.
- Prepare clinicians for direct work and decision-making while emphasizing and supporting clear pathways for consultation.
- Support clinicians with the personal impact of working with people who may be violent or may be perceived as violent.
- Provide training and resources that are accessible to new hires and useful to seasoned professionals alike.

FORMAL LEARNING GOALS

At the completion of the program, participants should be able to:

- 1. Explain the sources and impact of the myth of the "dangerously mentally ill."
- 2. Apply the risk factors of history and hostility in the clinical assessment of violence risk.
- 3. Develop a safety plan targeting dynamic risk factors for violence.
- 4. Explore reasons consumers may have for owning firearms and effectively discuss safer storage strategies with them.
- 5. Explain the impact of stress on clinical performance and identify basic strategies for improved self-care.

Course Director

John "Jack" Rozel, MD, MSL

Medical Director, resolve Crisis Services, UPMC Western Behavioral Health Co-director, UPMC Systemwide Threat Assessment & Response Team Professor of Psychiatry and Law, University of Pittsburgh

Dr. Rozel has been working in emergency mental health since 1990 and has been the medical director of resolve Crisis Services of UPMC Western Psychiatric Hospital since 2010. He is a Past President of the American Association for Emergency Psychiatry, the

leading national organization dedicated to the improvement of compassionate, evidence-based care for people with psychiatric emergencies. He divides his time between emergency psychiatry and violence work.

Dr. Rozel trains and consults with teams across UPMC and the country on projects related to violence and threat management, staff injury prevention, firearm injury prevention, and crisis and emergency psychiatry. He has served as an incident commander after mass shootings and been involved in the behavioral health response to several mass casualty events. He is a member of the Regional Gun Violence Research Consortium at the Rockefeller Institute of Government and has contributed to major policy efforts including the National Council for Behavioral Health's report on Mass Violence, the National Suicide Prevention Lifeline's violence management guidelines, and the AMA et al's Amici brief for the NYSRPA v Bruen case before the Supreme Court. He is the co-director of the UPMC Systemwide Threat Assessment and Response Team and works extensively with regional and national partners on behavioral threat assessment and management.

Dr. Rozel serves the Commonwealth of Pennsylvania as a member of the Citizen Law Enforcement Advisory and Review Commission, the Mental Health and Justice Advisory Committee for the Pennsylvania Commission on Crime and Delinquency, and the Threat Assessment Steering Committee for the Office of Homeland Security.

Dr. Rozel is board certified in general, child, and forensic psychiatry. He earned a bachelor's in biomedical ethics and an MD at Brown University and a Master of Studies in Law from the University of Pittsburgh where he also completed his general psychiatry residency and child and forensic psychiatry fellowships at Western Psychiatric Institute and Clinic of UPMC. Dr. Rozel is a Distinguished Fellow of the American Psychiatric Association and an Honorary Member of the American College of Emergency Physicians. He received the Exemplary Psychiatrist Award from the National Alliance on Mental Illness, the Behavioral Healthcare Professional of the Year from CIT International, and the Ralph C. Wilde Leadership Award from the Allegheny County Medical Society.

Dr. Rozel regularly provides clinical and didactic training to medical students, residents, and fellows at the University of Pittsburgh School of Medicine; mentors graduate students through the Center for Bioethics and Health Law; and co-teaches Mental Health Law at the School of Law. Dr. Rozel has been a CIT trainer for more than 10 years and provides training on violence and behavioral emergencies to a variety of regional and federal law enforcement professionals.
