




### **Overview of the Pediatric Shift Care Initiative**

From 2019 to 2020, Pennsylvania's Medicaid Program within the Department of Human Services, hosted a series of workshops and meetings with a wide range of stakeholders to **identify key issues families and caregivers of children with medical complexities face when living in the community** (specifically Medicaid Managed Care members under 21 receiving in-home shift care).

Purpose: To improve Pennsylvania's pediatric shift nursing model to better serve patients, families, home health care workers, and MCOs



Mission: To serve as the catalyst for stakeholder collaboration that results in the exploration and development of actionable solutions in five key areas of Pennsylvania's pediatric shift nursing model

Based on the workgroups, this collaborative group developed multiple recommendations to improve the system of care based on issues and obstacles faced by families and caregivers and summarized their work in a public-facing whitepaper. The whitepaper became the Commonwealth's action plan regarding how to best improve support for this community of children with medical complexities and their caregivers get the care and support they need.



# Overview of the Pediatric Complex Care Resource Centers (PCCRCs)

The Pediatric Complex Care Resource Centers (PCCRC) were developed by the Office of Medical Assistance Programs (OMAP) in partnership with the Office of Developmental Programs (ODP) to implement non-medical resources to provide support for caregivers and families of children and youth with medical complexities.



## **Caregiver Support and Training Hubs**

A key recommendation of the 2020 white paper centered around improving the nurse and caregiver relationship. To address this recommendation, the Pediatric Complex Care Resource Center (PCCRC) was designed to provide holistic support to the caregiver team – families receiving pediatric shift care services and their healthcare providers (e.g., home health agency) – by offering easily accessible support, information, and resources via online and in-person formats.

### Initiative creates 4 regional and online Pediatric Complex Care Resource Centers (PCCRC)



### **In-Home and Remote Support**

<u>Family Facilitators</u> – extends existing ODP program to support families transition from facilities/hospitals to community settings and to support the diversion of child placement in congregate care settings

<u>Pediatric Coaches</u> – provides in-home caregiver support and intervention, customize and facilitate training, and facilitate regional family advisory workgroups



### **Online Learning Options**

Online Trainings and Resources – self-paced learning courses on various home-care topics that are targeted for families, caregivers, and nurses to be delivered through the existing MyODP portal






# **Overview of the PCCRC Regions**


Pediatric Coaches and Family Facilitators will be hired by PCCRCs so there is coverage throughout the Commonwealth.

# Family Facilitator and Pediatric Coach Responsibilities

Provided directly through the PCCRCs, the Family Facilitator and Pediatric Coach have distinct roles to support families and caregivers feel ready and empowered to provide care in the home setting.

### **PCCRC Roles**





Helps with transitions out of a hospital/facility and supports ability to stay at home. Conducts outreach to families, community health/health promotional organizations, hospital/facility social workers, and discharge planners regarding in-home services and family-based alternatives.

The purpose of the Family Facilitator is to serve as a **liaison between departments**, to provide information to families, and assist with coordination and planning for in-home services and options for family-based alternatives to institutions.

Supports children receiving shift nursing services through **interventions with the caregiver team** by providing guidance regarding the parameters of each of the team members' roles and responsibilities. **Administers the in-person reach of online trainings**.

Pediatric Coaches also run **ongoing regional family advisory workgroups**. The purpose of the workgroups is to give families an opportunity to provide insight and feedback on.

# **Online Learning Objectives**

In collaboration with MyODP and a university partner, new online training is being created to provide self-paced curricula.

Purpose of Online Training Portal

To provide an easily accessible training portal via MyODP that will cover topics requested by family and caregivers of children with medical complexities. The topics are covered in 5 primary training objectives.

### Objective 1: The Fundamentals

Make available to all caregivers training that focuses on **supporting a child in their home**, including education focused on supporting **behavioral health** needs

### **Objective 2: DME**

Ensure all caregivers have access to training that focuses on the use of **Durable Medical Equipment** in individual home environments (i.e., how to use specific DME in specific environments)

### **Objective 3: Advocacy**

Make available to all caregivers training that focuses on creating improved health outcomes for children through inclusion in their family/community systems

### **Objective 4: Transitions**

Make available to all caregivers training that leads to **safe and efficient life transitions** for children and caregivers (e.g., congregate care to family homes; aging-out; hospital nursing to home nursing)

### **Objective 5: Relationships**

Make available to all caregivers training that leads to **improved collaboration** through relationship building amongst families, medical personnel, HHAs, and MCOs
