#### Introduction:

This course is intended for physician assistants, nurse practitioners, nurse midwives, and nurse anesthetists clinically practicing in both inpatient and outpatient medicine. This two-day multidisciplinary, interactive event aims to educate APPs on up-to-date treatments and best practice guidelines for a variety of topics, as well as improve interdisciplinary relationships between APPs across local hospitals in order to better serve their patients. The course will aim to enhance both clinical and procedural skills by offering a combination of didactic lectures and hands-on workshops.
