#### KEYNOTE SPEAKERS



Dr. Barbara Knox, MD, FAAP is a Professor of Pediatrics at the University of Florida College of Medicine in Jacksonville and a Child Protection Team physician for the University of Florida First Coast Child Protection Team. She is Chief of the Division of Child Protection and Forensic Pediatrics and the Fellowship Director for the Child Abuse Pediatrics Fellowship and Associate Fellowship Director for the Child Abuse Pediatrics/Pediatric Emergency Medicine Fellowship. Dr. Knox received her medical degree from the University of Wisconsin. She completed a residency in General Pediatrics and Adolescent Medicine at Mayo Clinic in Rochester, Minnesota. She then completed a fellowship in Child Abuse Pediatrics at Cincinnati Children's Hospital Medical Center in Cincinnati, Ohio, Dr. Knox is board certified in both General Pediatrics and Child Abuse Pediatrics. Dr. Knox has been working in the field of child abuse for 20 years. She has consulted with the FBI's Behavioral Analysis Unit III in Quantico, Virginia regarding violent crimes against children for many years. Areas of research interest for Dr. Knox include child physical/psychological torture as a form of child abuse and sexual torture as a form of child abuse. Dr. Knox was the lead author on the 2014 seminal research and publication on Child Torture as a Form of Child Abuse. Dr. Knox has published on many topics in child maltreatment, including child torture as a form of child abuse, burns of abuse, abusive head trauma, and is currently conducting research with the FBI's BAU III on various aspects of child torture. Dr. Knox is recognized nationally and internationally for her work in child abuse and child maltreatment prevention.



Dr. Elizabeth Zona is a double board-certified physician, specializing in both Anesthesiology and Addiction Medicine. She is a medical director for Anesthesiology at Three Rivers Endoscopy Center and Medical Director for Addiction Medicine Services at Laurel Care Treatment Center, both in the Coraopolis, PA area. She earned a BS in Pre-Medicine with Honors in Chemistry from Penn State's Eberly College of Science in 2002. She earned her medical degree from Philadelphia College of Osteopathic Medicine in 2006. After completing an additional 4 years of residency training at UPMC-Mercy she became board certified in Anesthesiology in 2011 and has been a practicing anesthesiologist for over 13 years. In 2016, after losing a friend to opioid overdose, Dr. Zona decided to take on the additional education and training in Addiction Medicine and became board certified in 2019. She has been active with addiction prevention efforts and treatment, while advocating for those in recovery, for over 6 years now. She is happy to speak further about medical school, the fentanyl epidemic, the dangers of counterfeit pills, alcoholism, nicotine dependence and more. Mr. Noel participates in the multidisciplinary review of child fatality and near fatality reports. 

As child abuse pediatrician and Professor of Pediatrics, she also served as chief of the division of Child Advocacy at UPMC Children's Hospital of Pittsburgh from 2013 until 2022. In addition to her clinical work evaluating children with concerns for abuse and neglect, she has spent over 20 years as a clinical researcher. Her research has focused on decreasing fatalities and near-fatalities in young children due to child maltreatment and unsafe sleep. Her child maltreatment research has focused on improving identification of suspected physical abuse using serum biomarkers, clinical decision rules and the electronic health record. Her work related to unsafe sleep has focused on improving consistent investigation and data collection and developing safe sleep education for high-risk populations. She led the Allegheny County Infant Child Death Review Committee from 2017-2022. Her research has been funded by the National Institutes of Health (NIH), the Patient-Centered Outcomes Research Institute (PCORI), the Centers for Disease Control (CDC), the Beckwith Institute, the Hillman Foundation and others. She has co-authored over 130 peer-reviewed publications and book chapters and was the first child abuse pediatrician to be elected to ASCI (American Society for Clinical Investigation). She has also been involved child abuse-related policy and served on the Pennsylvania Task Force for Child Protection, as the research lead for the Federal Commission to Eliminate Child Abuse and Neglect Fatalities (CECANF) during the Obama administration and as a senior policy fellow for Casey Family Programs in 2019.
